Subject: Conducting of Limited Departmental Competitive Examination for promotion to the post of LDC in CCRAS – Regarding.

Madam/Sir,

I am directed to refer to this Council Hqrs Office's letter No.2-8/2017-CCRAS/Rectt./Vol.I/7887 dated 16.02.2024 on the above subject and to enclose a list (Annexure-I), containing names of MTS, who are eligible, as on 31.01.2024, to appear in the Limited Departmental Competitive Examination for promotion to the grade of Lower Division Clerk (LDC) in Pay Level – 2 (Rs.19,900 – 63,200), in the CCRAS, including its different Peripheral Research Institutes.

- 2.1 The eligibility criteria for the above departmental examination is as under:
- (i) Group 'C' staff in the Pay Matrix Level -1 (Rs. 18,000-56,900) who possesses 12^{th} Class pass or equivalent qualification and have rendered three years regular service in the grade on the basis of departmental qualifying examination. The maximum age limit for eligibility for examination is 45 years (50 years of age for the SC/ST candidates).
- 2.2 The candidates should be clear from vigilance angle. Besides, their annual performance reports for the period of last five years, should be at least satisfactory.
- 3. The aforesaid written examination is likely to be conducted in the last week of June, 2024 at the Central Council's Headquarters Office in New Delhi and all the concerned Candidates should kept themselves well prepared for this Examination.
- 4. The scheme of Examination is as follows
- (i)(a) Written Examination In the aforesaid Examination there will be total four Papers, i.e., Paper I, II, III & IV and, all the said four Papers will be of objective type multiple choice only. There will be no negative marking. The details of the Written Examination are mentioned below:

- (i)(b)(i) The Typing test being part of the departmental examination, the MTS who are appointed as LDC on the basis of the written examination, should pass typewriting test within two years of their appointment as LDC, failing which they will be reverted to their earlier post of MTS. The Officials who are aged 45 years and more as on the date of their appointment as LDC are exempted from passing the type test. The MTS who are promoted as LDC based on the aforesaid examination and are aged less than 45 years as on the date of their appointment as LDC, should pass the typewriting test conducted by the State Board of Technical Education or by an organization/agency/board, etc., authorized by the Government.
- (ii) The question papers will be bilingual. The candidates shall have the option to answer the question paper either in English or in Hindi (in Devanagri Script). If answers are written partly in one language and partly in another language, such answer script will not be evaluated and such candidate will be awarded ZERO marks.
- (iii) The change in the scheme of examination, if any, will be informed through the website of this Council.
- 5. The points to be noted by the eligible Departmental Candidates are indicated in the attached List (Annexure-II).
- 6.1 In order to process the issue for holding the Limited Departmental Competitive Examination for promotion to the post of LDC in CCRAS and its Peripheral Research Institutes, the information/documents as follows are required by this Council:-
- (a) A confirmation that no discrepancy has been found in the particulars in r/o each employee indicated in the above List (Annexure-I), referred to in para 1 above. Alternatively, if any discrepancy is noted by the concerned Institute, the same may be brought to the notice of this Council immediately.
- (b) The Vigilance clearance in r/o the eligible candidates for whom it has not yet been received from the concerned Institute, as mentioned in col.10 in the List at Annexure-I.

- (c) Updated Annual performance reports for the period of last years, i.e., 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23, in r/o the eligible candidates for whom it has not yet been received from the concerned Institute, as mentioned in col.11 in the List at Annexure-I.
- 6.2 The information/documents w.r.t. para 6.1 (a), (b) & (c) above may be provided by the concerned Peripheral Research Institute to this Council immediately through official e-mail of the Research Institute at the following e-mail i.d. astendra.meena@ccras.nic.in and, ink signed hard copy(ies) thereof (in original) may be sent by Speed Post within 7 days of the receipt of this communication.
- 6.3. Besides, the information contained in paras 3 to 5 above may be brought to the notice of the eligible Candidate (s) by the concerned Research Institute and CCRAS Hqrs Office, New Delhi, immediately.

The points to be noted by the eligible candidates for the Limited Departmental Competitive Examination for promotion to the post of LDC.

- i) The candidates admitted to the examination will be required to produce (in original) valid Identity Proof bearing their Photo and address, viz., Departmental Identity Card/Aadhar Card/Driving License/Passport/Votor Identity Card, etc.;
- ii) Candidates are not eligible to receive any Travelling Allowance from the CCRAS HOrs;
- iii) No request for change of centre will be entertained under any circumstances;
- iv) Candidates should clearly understand that this is a competitive and not a mere qualifying examination;
- v) The candidates should be present in the examination Hall at CCRAS HQrs Office, New Delhi at least half-an-hour before the exam. They will not be allowed to leave the examination hall until the exams are over. Candidates arriving late will not be permitted to enter the Examination Hall, in any condition;
- vi) The following activities shall be considered as malpractices by the Central Council.

a)	Taking away answer book with him/her from the examination hall; or.						
b)	Impersonating; or						
c)	Submitting fabricated documents or document which has been tempered with; or						
d)	Making statements which are incorrect or false or suppressing material information;						
	or						
e)	Using unfair means in the examination hall; or						
f)	Found in possession of mobile phone/blue tooth device/any other electronic device/gadget in switched on or switched off mode inside the examination hall.						

- vii) After the examination, the names of finally selected candidates will be arranged in the order of merit along with aggregate marks finally awarded to each candidate so that the candidates who are found to be qualified in the examination shall be recommended for promotion as LDC;
- viii) The number of persons to be selected on the basis of the result of the examination is entirely within the competence of Government to decide. No candidate will, therefore, have any claim for promotion/appointment as LDC on the basis of performance in the examination as a matter of right.
