Theme Background

Patient safety is defined as "the absence of preventable harm to a patient and reduction of risk of unnecessary harm associated with health care to an acceptable minimum." Common adverse events that may result in avoidable patient harm are medication errors, unsafe surgical/para surgical/panchakarma procedures, health care-associated infections, diagnostic errors etc. Investing in patient safety positively impacts health outcomes, reduces costs related to patient harm, improves system efficiency, and helps in reassuring communities and restoring their trust in health care systems.

World Patient Safety Day (WPSD), observed annually on 17th September, aims to raise global awareness about patient safety and call for solidarity and united action by all countries and international partners to reduce patient harm. The Day brings together patients, families, caregivers, communities, health workers, healthcareleaders, and policy-makers to show their commitment to patient safety. (WHO, patient safety, 2023)

Considering the growing use of ASU & H products and medicines globally; inclusion of traditional medicines in Pharmacovigilance systems became equally important. Besides, the National Health Policy 2017 has emphasized on mainstreaming of Ayush services that will aid in contribution to meet the National Health goals and objectives through integrative practices.

CCRAS-Central Ayurveda Research Institute (CARI), New Delhi, along with Peripheral Pharmacovigilance Centre (PPvC) and National Pharmacovigilance Co-ordination Centre (NPvCC) is organizing a two-day National Seminar on "Fostering Patient Safety: Role of Diagnostic Practice in Ayush" to explore the integrated wisdom of Ayush systems & modern sciences on the diagnosis, treatment, and safety aspects.

Guidelines for Abstract submission.

- Abstract should be in MS Word with title (14 Font size), Name of the author, affiliation, email.
- Content of Abstract: Times New Roman, Font size 12, Line space 1.5, Word limit-Maximum 250 words.
- Abstract must be in stuctured IMRAD format: Background (Introduction), Aim/objective, Methodology, Results, Discussion with Keywords (3-5).
- Auther will be informed about the abstract acceptance (paper or poster) after evaluation by the scientific committee.

Guidelines for Oral/Poster Presentation

- The oral presentation must be prepared in PPT form.
- PPT presentation should not exceed 5+1 minutes.
- Recommended poster size is 2 feet (width) X 3 feet (height) in flex form.
- Last date for sending the abstract: 20th July 2024.
- Last date for full paper submission: 30th July 2024.
