### For Organizing 02 Day Training Programme on CCRAS Standardized Prakriti Assessment Scale and Ayur Prakriti Web Portal

Central Council for Research in Ayurveda Sciences (CCRAS) under Ministry of Ayush is an apex research organization committed to undertaking, coordinating, formulating, development and promotion of research on scientific lines in Ayurveda. The Council has developed a Standardized "*Prakriti* Assessment Scale" for capturing *Prakriti* of an individual with rationality, reliability, reproducibility and maximum objectivity. Based on this standardized Scale, the Council has developed a user-friendly device responsive portal viz. "AYUR *Prakriti* Web Portal" for assessment of an individual's *Prakriti*.

The Council's Standardized Prakriti Assessment Scale and AYUR Prakriti Web Portal has been included by National Commission for Indian System of Medicine in the BAMS syllabus. The Council intends to build the capacity of the Academicians, Researchers and Clinicians of Ayurveda nationwide on Standardized Prakriti Assessment Scale by providing hands on training on AYUR Prakriti Web Portal. The Expression of Interest from the interested Ayurveda Institutions / NCISM recognized Ayurveda Colleges is called for organizing the Training Programme on Standardized Prakriti Assessment Scale and AYUR Prakriti Web Portal.

## For Organizing 02 Day Training Programme on CCRAS Standardized Prakriti Assessment Scale and Ayur Prakriti Web Portal

### **Background**

The Central Council for Research in Ayurvedic Sciences (CCRAS) is an autonomous body under the Ministry of AYUSH, Govt. of India. The Council undertakes research on scientific lines in Ayurvedic sciences through its 30 peripheral Institutes/Centers/Units located all over India.

Prakriti assessment helps in prescribing diet and lifestyle advocacies for preventive and promotive health. It potentiates an Ayurveda Physician clinically, in prognosis, diagnosis and treatment of any disease (for deciding appropriate drug, dose, duration, diet and life style).

The Council has developed a **Standardized Prakriti Assessment Scale (SPAS)**. The Standard Operative Procedures (SoPs) for capturing each and every predictor of Prakriti has been developed and documented in the form of **Manual of Standard Operative Procedures (SoPs) for Prakriti Assessment Scale**. (Copyright L-76725/ 2018).

Council has developed user-friendly device responsive **AYUR Prakriti Web Portal**.

### Council's Prakriti Training Programme

Training on SPAS and hands on training on AYUR Prakriti Web Portal is essential for capacity building of Researchers, Clinicians and Academicians of Ayurveda nationwide. The Council has been organizing training programmes in Ayurveda Colleges across the country and has organized more than 20 training programmes till date where in approximately 600 faculty members and stakeholders from more than 150 Ayurveda Colleges have been trained. All the Council's technical officers of Ayurveda (approx. 200) from across the country have been trained and are using this portal for various research projects.

Trained Ayurveda stakeholders can assess Prakriti through AYUR Prakriti Web Portal and issue Prakriti Card. Prakriti Card can be referred by treating Ayurveda Physician as and when required. The Standardized Scale may be used by Researchers/PG/PhD/Post Doc Scholars/Practitioners of Ayurveda for their research/clinical work.

#### Call for Proposal for expression of interest

The Council intends to further disseminate SPAS for sensitizing on importance of Prakriti and benefitting the Ayurveda Fraternity at large. The Expression of Interest from the interested Ayurveda Institutions / NCISM recognized Ayurveda Colleges is called for organizing the Training Programme on Standardized Prakriti Assessment Scale and AYUR Prakriti Web Portal.

#### Eligibility criteria for the training

Any Ayurveda Institution /Ayurveda college recognized by NCISM may send the expression of interest for the training programme. The eligibility criteria of the participants of the training programme are BAMS Degree from an Institution recognized by NCISM, Completion of Internship, Registration with the State Ayurveda Council of Indian Medicine/ NCISM and Minimum knowledge of operating computer system.

#### Roles and Responsibilities of the Ayurveda College/ Institution for the Training Programme

The expenditure for organizing the training programme has to be borne by the organizing college/institution. The interested institution have to provide the venue & logistics for organizing the

training programme. The logistic support required at the venue of the Training programme are one Computer System with Internet connectivity among two participants, Projector for PPT presentation, Vernier Caliper, BP Instrument, Weighing Machine and Measuring Tape. The training kit includes the Manual of Standard Operative Procedures (SoPs) for Prakriti Assessment Scale that may be purchased for the trainees from the publication section of CCRAS prior to the training. The Manual costs Rs 250/- per manual. The publication section of CCRAS may be contacted on <u>publication-ccras@gov.in</u>.The organizing college/institution may also provide working lunch/tea/snacks to a maximum of 30 participants in one training programme.

### **Roles and Responsibilities of CCRAS for the Training Programme**

Resource persons from CCRAS will impart the training. Maximum 02 resource persons may be deputed for one training programme. The TA/DA and accommodation of the resource persons will be borne by CCRAS. Certificates of the training programme will be issued by the competent Authority of CCRAS in collaboration with the organizing college/institution.

#### **Tentative Training Programme Schedule**

The Training Schedule for Day-1 will be Training on the SOPs of Prakriti Assessment Scale along with demonstration of modules of AYUR Prakriti Web Portal. The Day 2 Training Schedule will be Hands on training on AYUR Prakriti Web Portal and Individual Practice and Assessment of training on SOPs of Prakriti Assessment Scale and AYUR Prakriti Web Portal.
