Sub:- Promotion of MTS on the basis of Centralized Seniority and conducting of Limited Departmental Competitive Examination for promotion to the post of LDC-reg.

Sir,

I am directed to state that promotion of MTS (all trades) possessing minimum qualification of 10+2 is under consideration to the post of LDC in terms of extant recruitment rules under following methods:-

- a) Promotion of MTS through DPC on the basis of Seniority against 5% quota of the available vacancies of LDCs.
- b) Limited Departmental Competitive Examination against 10% quota of available vacancies of LDCs.
- The provisional seniority list of MTS (all trades) is attached herewith for perusal and circulating to all concerned. In case, any name is left out of the provisional the same may be intimated to Council's Head quarter office for inclusion in the provisional seniority list provided one is possessing minimum qualifications of 10+2 pass. The zone of consideration shall be formed containing persons serving in any trade of MTS and possessing the minimum qualifications for promotion through DPC. As far as limited departmental competitive examination is concerned, the minimum qualification of the candidate should be 12th pass and should have rendered at least 03 years regular service as MTS in any trade or combined three years regular service in more than one trade of MTS on the closing date of inviting the applications.
- The candidates who are not possessing minimum essential qualification will not be included in the centralized seniority list for consideration of promotion or limited departmental competitive examination. Therefore, the persons not possessing minimum prescribed qualifications need not be forwarded for inclusion in the centralized seniority list. In case, no communication/objection is received from peripheral Institutes within 15 days of uploading and circulating the provisional seniority list, it would be presumed that no name is left out from the provisional seniority list or the concerned individual (stake holder) has nothing to say further.

On hearing from the Institutes within prescribed time limit, the final seniority list will be uploaded on the website for further action.

- 4. Applications are invited through proper channel within 30 days of the issue of this letter from desirous MTS (all trades) possessing essential qualification of 10+2 and having rendered not less than 03 years regular service as MTS (all trades) on the closing date of inviting applications to fill up the post of LDC from MTS through Limited Departmental Competitive Examination being conducted shortly. The peripheral Institutes are therefore, requested to provide Vigilance Clearance and satisfactory performance during the last 05 years while forwarding such applications. The Vigilance Clearance and satisfactory performance of last 05 years may also be provided in respect of 1st 10 candidates available in the provisional seniority list as attached for considering promotion on seniority basis. Willingness for promotion from MTS to LDC from Sl. No.1 to 10 (zone of consideration) needs also to be furnished.
- 5. Peripheral Institutes are requested to bring the contents of this letter into the notice of all MTS (any trade) working in the Institutes and make them aware of the Limited Departmental Competitive Examination being conducted at CCRAS Hqrs Office and forward the applications of interested candidates for that purpose within prescribed time limit.
