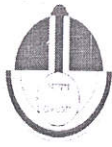


- I. In case the firm is unable to affect the supply of goods in stipulated time intervals or becomes insolvent, the loss incurred to the NARIP will have be borne by the person.

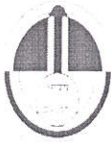

TENDER DOCUMENT, GENERAL TERMS & CONDITIONS FOR SUPPLY OF
REAGENTS/ KITS/OTHER ITEMS

Section 'A':- Tender for supply of Reagents/ kits/other items for the IMR project on Alzheimer's disease of the Institute.

The Institute is a part and parcel of Central Council for Research in Ayurvedic Sciences, New Delhi, which is an autonomous organization functioning under the aegis of Ministry of AYUSH, Govt. of India.

1. The tendering Companies/Firms/Agencies are required to enclose self attested/certified photocopies of the following documents along with the Financial bid.
 - a) Copy of income Tax, PAN card and shop Act License,
 - b) Copy of the G.S.T. registration certificate.
2. The supplier must be Authorized franchisee of the company(Please enclose the authorization certificate)
3. The terms & conditions and payment of bills may be specified.
4. The contract will be awarded subject to condition that the vendor will have to offer maximum discount. Revision of rates will not be accepted after entering into contract.
5. The supplier is bound to effect supply as per requirement within the stipulated period mentioned in the contract otherwise contract will be cancelled.
6. The Contract offer awarded to the firm would be effective from the day a written confirmation in company's letter head duly signed by an authorized signatory with name and designation, date and seal of company should be received within ten days from the date of issue of this letter, failing which it will be presumed that your firm is not interested in the said rate contract.
7. The rates quoted shall remain valid for the contract period. In case of satisfactory service, the contract may be extended for further periods as deemed fit as per the requirement.
8. On the basis of the quotation received from a firm, the Institutes letter informing them of the extent of acceptance of the same, including details of the items which they will be required to supply, shall be deemed as a concluded contract and the firm will be required to supply those items within 15 days of receipt of every purchase order from the Institute.
9. If a firm foresees a possibility that the requirement of the Institute cannot be met within the stipulated time period, it will inform the Institute of the same at the earliest possible and also state the additional time period within which the items can be supplied. The Institute will consider the same and take a decision whether the reasons given by the firm are justified and in case the Institute decides otherwise, it will be deemed as deficiency of service and the firm will be liable to forfeit the amount of performance Guarantee (if any).

10. The period of contract shall be for one year from date of award of contract extendable for one more year on same rate, terms & conditions subject to satisfactory performance of the agency/contractor.
