
QUOTATION NOTICE

Sealed Quotations are invited for supply of Ultra Sensitive Rat Insulin ELISA Kit to Pharmacology Department (IMR Project on Ficus gibbosa) of this Institute.

1. The rates quoted should be inclusive of all taxes and other charges viz. packing, forwarding etc. And should be firm for a period of one year from the date of opening of tenders and no request for increase in rates will be entertained during the period of agreement.
2. Firm who are authorised dealers for a particular manufactures may enclose a copy of the latest dealership certificate issued by the manufacturer/s. Such firms will be given preferential treatment among firms which have offered to supply the same product from that particular manufacturer.
3. The sealed Quotation “Quotation for Ultra Sensitive Rat Insulin ELISA Kit” should reach latest by 2.00PM on 31.08.17 and shall be opened at 3.00PM on the same day for which each firms may send its representative.
4. The Quotation submitted in response to this Quotation Notice and subsequent contract, if any, entered into, will be subject to the following conditions:-
  - (I) On the basis of the quotation received from a firm, the institute's Letter informing them of the extent of acceptance of the same, including details of the items which they will be required to supply, shall be deemed as a concluded contract and the firm will be required to supply those items within 15 days of receipt of every purchase order from the Institute.
  - (II) If a firm foresees a possibility that the requirement of the Institute cannot be met within the stipulated time period, it will inform the institute of the same at the earliest possible and also state the additional time period within which the items can be supplied. The institute will consider the same and take a decision whether the reasons given by the firm are justified and in case the institute decides otherwise, it will be deemed as deficiency of service and the firm will be liable to forfeit the amount of performance Guarantee.

5. Firms are required to submit their quotation along with a copy of the Quotation Notice, duly signed by the same signatory who has signed the quotation, in confirmation of the fact that they are agreeable to the terms and conditions stipulated therein.
