

CENTRAL COUNCIL FOR RESEARCH IN AYURVEDIC SCIENCES

NOTIFICATION

This is with reference to pre-bid Conference held at CCRAS on 16 April, 2018 in connection with "Request for Proposal" inviting sealed proposal under two bid systems for outsourcing recruitment related activities for Research Officer, Asstt Research Officers, Research Asstt and Staff Nurse.

Consequent to discussion held in the pre-bid Conference clarifications/amendments are made to RFP as per details given below:

1. EMD is Rs.3,00,000/- (Rs Three lakhs only).

2. In Page 2 of RFP, sub Para (k) may be deleted and substituted as under –

"(k) The computer based test is to be conducted in one single shift simultaneously in all centres for one particular discipline of the post."

3. In Page 3 of RFP, at the end of Para 8 add the following:

"Transaction charges, if any, will be borne by the candidates".

4. Page 3 of RFP, at the end Para 14 add the following:

"A help-desk needs to be made operative which shall be functional on all days from 09.00 A.M. to 6.00 P.M starting from first day of receipt of applications and till the date of examination".

5. Page 3 of RFP at the end of Para 18 add the following:

"A centralized control room should be available to redress the grievances of candidates through telephone, SMS, e-mail". The centralized control room needs to be made operative and shall be functional on all days from 09.00 A.M. to 6.00 P.M starting from first day of receipt of applications and till the date of examination".

6. In Page 4 of RFP, at the end of Para 26 add the following:

"The candidates entering the examination centres will be physically frisked but separately for male and female. For female candidates, frisking shall be in secured/covered room by female only".

7. In Page 11 of RFP, under J) – Performance Security –

After Para 2 add the following as Para 3:

"It is clarified that adequate opportunity of representation shall be given to the company/agency".

8. In page 15 of RFP, under 53 A) – Confidentiality –

Sub Clause (vi) may be treated as deleted.

9. Page 20 of RFP- Appendix 'D' - Format for quoting rates-

The existing page may be deleted and substituted as under:

1(a).	Cost for development of software for registration of online application, finalization of data and issuance of e-admit cards, preparation of question paper for each discipline of post, conduct of computer based online written examination at various designated centres and preparation of results for candidates upto 4800 candidates	Rs.
1(b).	Cost per candidate beyond 4800 number of candidates	Rs.
2(a).	Total cost for conduct of online exam for AYUSH NET 2018 for 1000 candidates	Rs.
2(b).	Cost per candidate beyond 1000 candidate for AYUSH NET	Rs.

Notes:

1. The cost quoted above should be exclusive of taxes and applicable taxes may be shown separately.
2. Conditional rates/quotes are liable to be rejected summarily.

10. **Selection of Bidder:**

The selection of bidder will be based on QCBC system. A copy of Criteria under QCBC system being adopted for selection of bidder will be placed on the Council's website on 24 April, 2018.

Additional Information

An online examination for selection of candidates for AYUSH-NET 2018 for sixty AYUSH Ph D Fellowship may be conducted through the agency selected. The number of likely candidates applying for the same will be 1000. The rate for the same may also be quoted separately in the Appendix D of RFP by the bidding companies.
