The Bids may be submitted in accordance with terms and conditions of e-procurement (for Tender cum auction) on above mentioned date and time in sealed cover through **e-Procurement module of CPP Portal only (www.ccras.nic.in)** super scribed with the tender number and date. The bidders must sign all the pages of Tender Form and Terms and Conditions as a token of acceptance of the tender conditions.

Technical Eligibility of the Bidders :

The bidding company /individual should have a valid PAN and GST Registration. (Copy to be enclosed)

The bidder should be registered with Central / State Pollution Control Board and should have the valid license. A copy of the valid license should be enclosed along with the offer. Non-submission of a valid license will render the tender as invalid and will be rejected.

The bidder must have executed at least one contract of auction amounting to Rs.10.00 Lac or more during last three years. (Copy of the sale order has to be enclosed).

Mode of Selection :

The H1 bidder meeting the technically eligibility shall be awarded the contract. If the H1 bidder fails to execute the contract within the stipulated period, institute may at its discretion award the contract to the next lower bidder at the H1 price.

Terms and Conditions and General Information :

The inspection of the material can be done as per the date and time mentioned above on prior appointment only.

The bid should be submitted through e-Procurement module only as per the format given in the Tender document within the stipulated date and time mentioned above. Bids received after the due date cannot be considered. All bids should be super scribed with the text "Tender for Disposal of Obsolete and Scrap Items" with tender number and due date.

The bidder should quote the price in the Price-Bid excluding the taxes and duties. All Taxes and duties are to be paid extra, as applicable, at the time of making payment.

The EMD and Tender Fee as mentioned above has to reach The Assistant Director Incharge, RARI, Agamkuan, Patna- 800007 within 11:00 A.M. on 08.05.2023. The bids without EMD and Tender Fee shall not be considered. The EMD shall bear no interest. The EMD of un-successful bidders will be returned within one month from finalization of the tender and successful bidder will get back their EMD after completion of the contract (which includes lifting of the materials and cleaning the site to the satisfaction of institute authorities).

It is the responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.

The sale of the materials shall be on "As is where is basis".

Bidders cannot withdraw their offer after opening of the bids.

The full payment of the offer price must be deposited by the successful bidder within 7 days from the date of issue of the Sale Order.

The successful bidder will have to lift the entire material and clean the site at its own cost within 15 days from the date of issue of the Sale Order.

The quantities mentioned against each scrap items are approximate and the sale will be effected at actual at the time of taking delivery.

The lists of items shown are indicative. The Assistant Director Incharge, RARI, Patna reserves the right to add/delete/modify as found necessary.

All labour, tools and equipment for loading the items from RARI, Patna site to the buyer's trucks with all leads, lifts, etc. shall be at the cost of the buyer.

While lifting the material, if the bidder is found to damage institute properties, he will be liable to pay the cost of repair, as assessed by the institute.

The personnel engaged by the bidder for the lifting of the materials shall strictly obey the safety rules in force.

Employees of the institute, individuals related to them and organizations in which institute employee or his/her close relative hold stake are not eligible to quote.

All payments are to be made in the form of DD/Banker's Cheque drawn on any scheduled bank at Patna and made payable to the Assistant Director Incharge, RARI, Patna. On the reverse side of the DD/Banker's Cheque the name of the company/bidder should be written along with the Tender No.

The institute reserves the right to accept or reject any offer OR cancel the tender altogether, without assigning any reason thereof.

The disputes, legal matters, court matters if any shall be subject to Patna jurisdiction only. In all matters, the decision of the Assistant Director Incharge, RARI, Patna will be final and binding.

Removal and transportation of materials shall be done only during working hours of RARI, Patna. No materials will be allowed to go out after 5.00 P.M. on weekdays. Similarly, no materials shall be allowed to go out on holidays.

The bids should be valid for **60 days** from the date of opening of the bids.

The tenders shall be written legibly and free from erasing and overwriting. Corrections if any should be duly attested by the authorized signatory.

The technical eligibility data along with the attested copies of the supporting documents should be submitted by the bidders as per the format given in **Annexure -B and the Price-Bid to be submitted in given in Annexure-C.** The bidder has to quote the offer price on a consolidated basis not item-wise/department-wise. Price should be written both in words and figures.

The institute may at its discretion relax any of the technical eligibility criteria for the bidders.
