## (A) बोलियाँ प्रस्तुत करने से संबंधित सूचना और शर्तैं/ Information and Conditions relating to Submission of Bids

The tender document containing eligibility criteria, scope of work, terms & conditions and draft agreement will be available for download on CCRAS website <a href="www.ccras.nic.in">www.ccras.nic.in</a>, CPPP website <a href="www.eprocure.gov.in">www.eprocure.gov.in</a> and <a href="www.tenderwizard.com/TWEPROC">www.tenderwizard.com/TWEPROC</a> from <a href="mailto:29.10.2022">29.10.2022</a> to <a href="mailto:18.11.2022</a>.

- 1. The interested firms/suppliers are required to submit their Technical and Financial Bids separately in the e-format available on the e tendering portal on or before 4.00 PM on 18.11.2022. The Technical bids shall be opened at CARI, BBSR in presence of the bidders or their authorized representatives on 19.11.2022 at 11.00 AM.
- 2. All the annexure of the documents should be numbered and signed properly by the owner of the firm or his Authorized signatory with seal before attaching the file. In case the tender is signed by the Authorized signatory, a copy of the power of attorney/authorization shall be enclosed along with tender. A copy of the terms & conditions shall be signed on each page and submitted with the technical bid as token of acceptance of terms & conditions.
- 3. Tender with unsigned pages/incomplete/partial/part of tender will be rejected.
- 4. The bidder shall pay the respective amount of Bid Security (EMD) along with the Technical Bid by Demand Draft in favour of "Central Ayurveda Research Institute, Bhubaneswar" drawn on any Nationalized Bank/ Scheduled Bank and payable at Bhubaneswar and must be valid for three (3) months. If, due to any unforeseen circumstances, the tender process is delayed, the tenderer has to revalidate the expired DD of EMD amount at their own cost as demanded by the competent authority.
- 5. The bid security (EMD) without interest shall be returned to the unsuccessful bidders within 30 days after opening of technical bid/ finalization of contract.
  - The successful bidder has to accept the Letter of Award within 15 days. If the successful bidder fails to accept the Award of Letter within 15 days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by CARI, BBSR,ODISHA. The successful bidder has to constitute a contract agreement on Indian non judicial stamp paper of Rs.100/- (Rupees one hundred only) and also required to furnish the performance security @ 10% of contract value in the form of Fixed Deposit or Bank Guarantee, for a period of 26 months, of any nationalised bank in favour of Central Ayurveda Research Institute, Bhubaneswar and payable at Bhubaneswar only. The EMD

deposited by successful bidder shall be returned after the submission of performance security as demanded above within 21 days after the issue of Letter of Award. If the successful bidder fails to furnish the full performance security within 21 days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by Central Ayurveda Research Institute, Bhubaneswar.

- 6. The performance security shall be forfeited if successful bidder fails to supply the equipment within 20 days of Letter of Award unless time extension has been granted by Central Ayurveda Research Institute, Bhubaneswar or fail to comply with any of the terms and conditions of the contract or fail to sign the contract.
- 7. The bid shall be valid and open for acceptance of the competent authority for a period of 180 (one hundred eighty) days from the date of opening of the tenders and no request for any variation in quoted rates and /withdrawal of tender on any ground by bidders shall be entertained.
- 8. To assist in the analysis, evaluation and computation of the bids, the Competent Authority, may ask bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.
- 9. After evaluation, the work shall be awarded to the agency fulfilling all the conditions and who has quoted the lowest rate as per financial bid after complying with the all the Acts/provisions stated/referred to for adherence in the tender.

#### (B) Other Terms and Conditions of the Tender

- 1. All the rates should be mentioned in Indian national currency (INR) only.
- 2. Rates quoted should be inclusive of all applicable taxes, levies, freight, packing, forwarding, postage insurance, delivery and installation (F.O.R.) at Central Ayurveda Research Institute, Bhubaneswar.
- 3. In case of imported items / equipments the rates should be quoted in the light of exemptions enjoyed by research institutions, otherwise bid will be considered as invalid. The Institute (Council) is registered with Department of scientific & Industrial Research (DSIR) for the purpose of availing custom duty exemption and the necessary certificates/forms can be issued by the Institute.
- 4. If the price of the contracted articles is/ are controlled by the Government, in no circumstances the payment will be higher than the controlled rate.
- 5. Tender will be regarded as constituting an offer open to acceptance in whole or in part at the discretion of the competent authority of the institute for a period of 180 days (6 months) valid from the date of opening of the tender by the committee.



- 7. The time for the date of delivery/ dispatch stipulated in supply order shall be deemed to be essence of the contract and if the supplier fails to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch in the supply order, liquidated damages may be deducted from the bill @ 0.5% per week subject to maximum of 10% of the value of the delayed goods or services under the contract. The competent authority of the institute may also cancel the supply. In such a case, bid performance security of the supplier shall stand forfeited.
- 8. In case the quality of goods supplied are not in conformity with the standard given in tender and as per the samples supplied/demonstrated or the supplies are found defective at any stage these goods shall immediately will be taken back by the supplier and will be replaced with the tender quality goods, without any delay. The competent authority reserves all rights to reject the goods if the same are not found in accordance with the required description /specifications and liquidated damages shall be charged.
- 9. In case the Tenderer, whom the supply order has been placed, fails to make supplies within the delivery schedule and the purchaser has to resort risk purchase, the purchaser (Central Ayurveda Research Institute, Bhubaneswar) may recover "risk purchase amount" from the bid security deposit (10% of Tender Value) of the Tenderer. In case of repeated failure in supplying the order goods, the supply order may be cancelled and bid performance security deposit will be forfeited.
- 10. The quantity of the instruments mentioned is approximate and is subject to increase/decrease at the discretion of the competent authority of Central Ayurveda Research Institute Bhubaneswar. The payment would be made for actual supply taken and no claim in this regard should be entertained.
- 11. Where the specifications are as per Tenderer's range of product & Tenderer's offer should mention that the item meets all specifications as per the tender enquiry and if there are improvements/deviations the same should be brought out on separate Letter Head of the firm or also be discussed/clarified in pre-bid meeting. It would be discretion of the competent authority of the institute to accept or reject such deviations which are not in accordance with our required specifications.
- 12. It must be mentioned clearly whether Tenderer is a manufacturer (OEM)/sole distributor/sole agent for the items for which he is quoting Assemblers of Equipments are not eligible to participate in tender.
  - a. **Manufacturer** must add a certificate of original equipment manufacturer (OEM) and item(s) manufactured by them as per range of products.

- b. **Sole Distributor** must add a certificate that they are the sole distributor of the Item for which they are quoting in this tender enquiry & item is /are their proprietary Item in India. The rate certificate is also required from the sole distributor that the rates quoted are the same as they quote to other State/Centre Govt./reputed Private Organisation and DGS&D rate for the similar item(s) and these are not higher than those quoted by them.
- c. *Authorized agents* must add authority letter from their Manufacturer/ Principals on the letter head of the manufacturer/principals in proforma given in **Annexure IV** duly supported by an undertaking that they are quoting Rates on behalf of them. The authorization letter must give/mention the purpose for which it is allowed. The validity period of the authorization letter must be mentioned in the authority letter otherwise tender will be liable to rejection.
- 13. Performance Certificate: A Certificate about satisfactory performance & quality of after sales service of the equipment duly authenticated by the HOD/MS of the institution must be furnished as per Annexure V. Installation report/user list will not be considered as Performance Certificate. The Tenderers should submit photocopies of the GST registration number, Income Tax return of last Three years and Balance sheets of last Three years in Technical Bid.
- 14. Full description & specifications, make/brand and name of the manufacturing firm must be clearly mentioned in the tender failing which the tender will not be considered. The Tenderer must also mention whether the goods are imported/ indigenous. Descriptive literature /catalogues must be attached with the tender in original failing which tender may be ignored.
- 15. Any failure or omission to carryout of the provisions of this supply by the supplier shall not give rise to any claim by supplier and purchaser one against the other, if such failure or omission arise from an act of God (natural calamities, civil strikes, lockout, strikes, riots, epidemic, war etc.) provided that notice of the occurrence of any event by either party to the other shall be within two weeks from the date of occurrence of such an event which could be attributed to *force majeure*.
- 16. <u>Payment Terms</u>: No advance payment will be provided by this Institute.

  Payment will be issued after the receiving of (a) Delivery receipt of material in good condition, (b) Full Installation Report, (c) Satisfactory Running Report of Instrument Issued by Concerned Section and Competent Authority and (d) Successful Training of Institute Staff.
- 17. The Courts at Bhubaneswar alone and no other Court will have the jurisdiction to try the matter, dispute or reference between the parties arising out of this tender/ supply Order/contract.

- 18. Tenderer will have to provide complete <u>warranty for all equipments for 5 (five) years as well / CMC (5 years) after expiry of 5 years warranty period in financial Bid.</u> Financial bid should be quoted accordingly. In this regard, the Tenderer shall submit an undertaking on Company's letterhead that they will provide complete onsite warranty of 5 (five) years, AMC and CMC for next 5 (five) years after expiry of 5 years warranty period of these equipments.
- 19. If at any time, any question, dispute or difference whatever shall arise between supplier and the institute (Purchaser) upon or in relation to or in connection with the agreement, either of the parties may give to the other notice in writing of the existence of such a question, dispute or difference and the same shall be referred to two arbitrators one to be nominated by the institute (Purchaser) and the other to be nominated by the supplier. Such a notice of the existence of any question dispute or difference in connection with the agreement shall be served by either party within 07 days. Before proceeding with the reference the arbitrators shall appoint/nominate an umpire. In the event of the arbitrators not agreeing in their award, the Umpire Appointed by them shall enter upon the reference and his award shall be binding on the Parties. The venue of the arbitration shall be at Bhubaneswar, (ODISHA.), India. The arbitrators/Umpire shall give reasoned award.
- 20. Tenderer should ensure and give an undertaking with technical bid that spare parts and consumables for these equipments/instruments will be available and rates will be reasonable for next 10 (ten) years.
- 21. Pre-Installation Visit: Tenderer or technical expert of tenderer firm must personally visit the institute for pre-installation facilities and in that case all the expenses will be borne by the supplier (if required).
- 22. Training: After award of the work, onsite training of equipments within the stipulated time should be done by the supplier at his cost. The time and place of training shall be stipulated by purchaser. Training should be of minimum 2 Scientists and 2 technicians of user department or any Scientists/staff recommended by competent authority (if required).
