


CIRCULAR

As per directions of the Ministry of Ayush, the Council has switched over from the existing system of filing of APARs in physical form to online e-SPARROW Portal from the year 2022-23 onwards. The APAR forms for all categories of officers/officials have also been uploaded on the e-SPARROW Portal. All Nodal Officers at CCRAS Hqrs. Office as well as Peripheral Institutes have also been notified vide Office Order No.7-1/2020-CCRAS/Vig/1498 dated 29.03.2023 and subsequent No.7-1/2020-CCRAS/Vig/1314 dated 31.05.2023 [copies enclosed].

- 2. Training for filling up of APAR through e-SPARROW portal has also been imparted to officers/officials of the Council Hqrs. Office and peripheral institutes by the IT Section of CCRAS Hqrs.
- 3. It has been observed that despite the clear instructions of the Council Hqrs. Office on several occasions to follow timelines, APARs are still pending for finalization at various stages i.e., filing of APAR, reporting, reviewing and acceptance of pending APARs etc.
- 4. Accordingly, the Competent Authority has decided to extend timelines for the year 2022-23 only as under:
