**General Information to the candidates:-**

1. A written test followed by interview will be held for the post of SRF and Pharmacist. Candidates who qualifies in written test will be called for interview.
2. Six posts of Senior Consultant, two post of SRF and two posts of MTA are for Ayurvedic Health Centre, extension centre RARI under North East plan in **different places of Sikkim**. One post of SRF for Mobile Health Care Research Project under SCSP, have to perform health camp 4-5 days per week.
3. Age limit of the candidate will be determined as **on date of interview**. Relaxation in case of SC/ST/OBC candidates as per Government rules.
4. The engagement of above post are initially for a period for six month which may be curtailed or extended at the discretion of the competent authority on the basis of work performance and their engagement will be co-terminus with the project.
