2. Applicants should bring their Bio-data along with original certificates, experience certificate etc. with a set of photocopies and two recent passport size photographs.
3. Age will be reckoned as on 01.11.2017. Age relaxation will be admissible for SC/ST/OBC/PH persons in Govt. Services as per Central Govt. rules in force.
4. The engagement of S. No. 2 post is for Ayurveda Mobile Health Care Programme under SCSP Programme. The engaged person should be ready to travel and work in villages and colonies near Ahmedabad (Gujarat).
