- 3) **Condition of lots:** The lots are sold on "as is, where is" basis and no guarantee is given for size, measurement, quantity and quality etc. The Tender sale is strictly on the assumption that bidders have inspected the items. No complaint/claim by the purchasers will be entertained in this regard.

- 8) The Earnest Money Deposit of all other bidders [expect the successful bidder (H1)] will be returned within 30 days of notification of the award of contract to the successful bidders.
- 9) Bid Validity: The bids shall be valid for 90 days from the date of opening of the bid. The bidders shall not be entitled, during the period of validity of their offers without the consent in writing from RARI, Ahmedabad to revoke or withdraw their bids or change in any respect their offer or any terms and conditions thereof in case of a bidder revoking or withdrawing his bid or changing any terms and conditions in regard thereto without the consent of RARI, Ahmedabad in writing, then RARI, Ahmedabad may at their discretion forfeit the EMD furnished by the bidder along with his offer.

In addition to this, bidder may be debarred from bidding for a period as may be considered fit by RARI, Ahmedabad, against any bid that might be invited by them in future RARI, Ahmedabad will also be within its rights to circulate the information, at its discretion to other prospective purchasers about the bidder having withdrawn his offer within the Validity period.

- 10) **Opening of Bids:** The offline Technical and Financial bids will be opened on the date specified under the Critical dates of tender, in the presence of the authorized representatives of the bidders present (if any), Representatives, of the Bidder(s) seeking to be present shall submit a Letter of Authority issued by the Bidders(s) stating name and contact no. along with photo copy of government Id.

- 14) The condemned materials must be removed after complete payment within 02 working days from the date of issue of Sale Order/Letter, at their own cost, either in the presence of successful bidder or an agent duly authorized by him (in writing in this behalf). The required manpower for the lifting of the items shall be arranged by the bidder himself at his own cost. After removal of the materials, the successful bidder shall leave the storage place of the materials neat and clean.
