सामान्य निर्देश एवं शर्तें / GENERAL INFORMATION AND CONDITIONS

अभ्यर्थियों को आवेदन प्रेषित करने से पूर्व सभी निर्देशों को ध्यानपूर्वक पढ़ लेने की सलाह दी जाती है।
Applicants are advised to read all instructions carefully before sending their applications.

1. अभ्यर्थी भारत का नागरिक होना चाहिए।
The applicant must be a citizen of India.

2. सभी अभ्यर्थियों को आवेदन प्राप्त की अंतिम तिथि तक संबंधित पद हेतु निर्धारित अनिवार्य योग्यताओं एवं विज्ञापन में उल्लिखित अन्य सभी शर्तों को पूर्ण करना आवश्यक है। आवेदन करने से पूर्व अभ्यर्थियों को यह सुनिश्चित कर लेना चाहिए कि वे संबंधित पद के लिए निर्धारित सभी अनिवार्य पात्रता मानदंडों को पूरा करते हैं। पात्रता के संबंध में परामर्श अथवा स्पष्टीकरण हेतु किए गए किसी भी प्रकार के अनुरोध पर विचार नहीं किया जाएगा।

All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement as **on the last date of receipt of the applications**. A candidate(s) can apply for more than one post for which he/ she is eligible. Such candidate(s) shall have to apply separately for each post and make appropriate selection for each post.
