3. Keeping in view the guidelines on compassionate appointment issued by the DOP&T from time to time and the Ministry of Ayush, vide OM No.B-

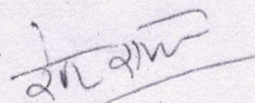

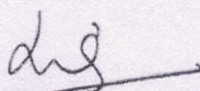
