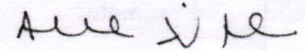

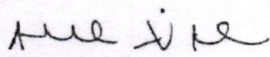

Note 1: If the departmental Officer is selected for appointment to the post, it is to be treated as the post having been filled by promotion and in case of an Officer is selected on deputation, the post is to be treated as filled on deputation and on completion of the tenure of the officer on deputation, the post would be re-advertised and the eligible departmental Officer will again be considered along with applicants, called afresh, for deputation; Note 2: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for appointment by promotion. Note 3: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government/State Government, etc. shall ordinarily not exceed three years.
